That Los Feliz Boulevard is practically the only street in town so far unspoiled by "spot zoning" for business purposes is not an argument for ruining it also. Time after time the City Council and the City Planning Commission have refused "spot zoning" applications for this street, but the appliers are persistent and the City Planning Commission--which seems to be running in reverse gear a good deal of the time lately -has this time yielded to their arguments.

Such arguments could only be commercial; that is, the petitioner could urge that the change would benefit him personally and financially. He could not urge that the change is needed or wanted, either by the city at large or by the residents of the neighborhood. There is plenty of business property in the vicinity already, which satisfies the needs of the residents, and there is an overplus of business property in the city as a whole. Further business zoning can only depreciate the value of property already in use for such purposes, and thus have a bad effect on the whole community, and on its ability to pay taxes.

The zoning law, if it means anything, means that property owners will be protected, when they buy property for residence purposes, against business encroachment, until there has been such a change in the neighborhood or in the city as a whole as to make a change in the character of the property desirable. Certainly there has been no change in the Los Feliz district which warrants its destruction as a street of beautiful homes, nor is such a change likely in the near future; unless, of course, this business application is granted. That will be an opening wedge for a swift overturning.

The precedent heretofore set should be followed and the present zoning of Los Feliz Boulevard should be maintained intact.

There has been one illustration in Chicago of the truth of Mr. Hoover's statement that the States can clean up their own criminality if there is public sentiment to do so.

Here is the case of "Fur" Sammons, murderer, gumman and bootlegger, who has been at liberty for a number of years on "parole," granted after he had been reprieved fortyeight hours before he was due to suffer the death penalty for a murder committed in 1903. Sentence was commuted to life imprisonment and later, in 1923, to fifty years by Gov. Len Small. Within a month there-after Sammons, by some hocus-pocus after Sammons, by some hocus-pocus known to Illinois justice, was released on parole. Hauled up a few weeks ago on a charge of vagrancy, it is now suddenly discovered that parole was not applicable in case of a commuted sentence, and Sammons has been returned to the penitentiary to serve the balance of his term, which means thirty years.

This is an amazing development in the administration of justice. one which throws a high light on the strange doings of the IIlinois courts. But, accepting the facts as stated and assuming that the action taken is to be attributed to a reawakened sense of the State's responsibility for suppression of crime, the case bears out the President's proper stand that the State, not the Federal government, is the agency which must act.
